Specification

1. Materials to be used
 - a) Body structure: FRP with metallic reinforcement
 - b) Exposed body surface like face, hand, feet etc. to be made with silicone rubber with flexifoam backup.
 - c) Clothing, shoes and other accessories: Actual, matching with the style as shown in the images.

2. Statue Height:

Item 1: Silicone Hyper Realistic Sculpture – Life size while standing posture figure of Srila Bhaktivinoda Thakur for period room setting. Height of the figure while standing is 5ft. 8 inch (sitting posture according to the height as per the attached image).

Item 2: Silicone Hyper Realistic Sculpture – Life size standing posture figure of Prabhupada bhaktisidhanta Sarasvati Thakur for period setting. Height of the figure while standing is 5ft. 8 inch
(Standing posture according to the height as per the attached image.)

3. Body posture should be as per the attached image.

4. Limb and body proportion should be as per standard anatomical dimension of human being.

5. The portrayal of face should bear a resemblance to the respective personalities (as per attached image)
6. Full size clay model to be prepared on the basis of the image supplied by the authority to obtain approval of the artwork. Necessary correction if required, to be incorporated in the clay model.
7. Finish should be hyper realistic look alike with actual drapery and accessories.
8. The statues are necessary to be delivered and installed at the site of installation in Kolkata.

Delivery Period and inspection Schedule

For Item 1 : 30 days from the date of placement of order.

- a) Clay model should be completed in first 15 days for obtaining approval during first inspection.
- b) Silicone cast shall be inspected in next 25 days.
- c) Complete statue shall be inspected at the site of fabrication prior to delivery.

For item 2: 40 days from the date of placement of order.


- a) Clay model should be completed in first 20 days for obtaining approval during first inspection.

Item 1: Life size sitting posture figure *Srila* Bhaktivinoda Thakur









