Instructions for Online Bid Submission

- 1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
- 2. More information useful for submitting online bids on the CPP Portal may be obtained at https://eprocure.gov.in/eprocure/app

REGISTRATION

- 1) Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.

SUBMISSION OF BIDS

GENERAL TERMS & CONDITIONS (GTC) FOR SUBMISSION OF TENDER FOR FABRICATION AND SUPPLY OF 'SCIENTIST BUST STAND' STRICTLY AS PER ENCLOSED DRAWING AND TECHNICAL SPECIFICATIONS.

01. Bidders should have necessary infrastructure and facilities so as to take up the job of fabrication and supply of the tendered items strictly as per council's specifications and drawings with required financial capability.

02. Price:

The prices and rates indicated/quoted shall be inclusive of cost of materials, fabrication and supply of the rate of GST and any other taxes/levies to be imposed on the rate shall be clearly mentioned. Prices and rate quoted shall be firm and fixed for the entire period of execution of the order and no escalation of rate on any ground whatsoever shall be applicable.

- 03. The successful bidders shall submit the following documents within 7(Seven) days from the date of Placement of the order:

04. Delivery Schedule:

Time is the essence of this tender. 05. Penalty Clause:-

- 06. The Council may extend the time of delivery of the ordered items at their discretion on the application of the successful bidder for such purpose provided that the Council considers the reasons for such extension as good, sufficient and acceptable.

Any defect pointed out during such inspections has to be promptly rectified to ensure desired quality of work. It would be mandatory on the part of the successful tenderer to arrange inspection and obtain approval at every stage of the work as detailed above, failing which action shall be taken as will deem fit by the Council. 09. Payment terms:-

No advance payment shall be made by the Council on any circumstances.
