No.9-28/2010-M.II dated 24.02.2016 and implemented as per NCSM Office Order No.06/2016 dated 26.02.2016.
2. It is understood that the Governing Body had approved the higher grades. Certified true copies of the relevant extract from the Minutes of the Governing Body in this regard information may be furnished.	The copies of the minutes of G.B can be provided on payment of Rs.4/- by way of demand draft or I.P.O. to be drawn in favour of "National Council of Science Museums" payable at Kolkata.

Certified true copy of the Notes containing approval of appointment/placement/ promotion of Secretary and Finance Officer and SSPO in National Council of Science Museums, Kolkata to the Grade Pay of Rs.8,900/- and Rs.8,700/- respectively.	The posts of F.O / SSPO & Secretary, NCSM were upgraded to Rs.8,700/- & Rs.8,900/- as per approval of Cadre Review approved by the HCM and President, NCSM as per the letter No. F. No.9-28/2010-M.II dated 24.02.2016 of MOC. A copy of the same will be provided on payment of Rs.2/- by way of demand draft or I.P.O. to be drawn in favour of "National Council of Science Museums" payable at Kolkata.
