## ANNEXURE

Continuation Sheet of our Enquiry No. I-18012/2/18(250) dated 06.12.2018

The specification for the fabrication of Fibreglass Scientist Busts is as follows:-

1. Name of the Scientist :Homi Jehangir Bhabha, Birbal Sahni, J.C. Bose, Srinivasa Ramanujan, C. V. Raman, Meghnad Saha, VA Sarabhai and Satyandranath Bose
- 2) Quantity : 5 sets (each set comprising of 8 Scientist Busts along with 2 Spectacles in two busts), total 40 nos.
- 3) Size : 2' – 6" height and 2' width approx.
- 4) Thickness : 4 layers in each part of casting.
- 5.) The process of casting and finishing of the whole job will comprise of the following procedure, which has to be strictly adhered:
  - a) There shall be four layers in each part of casting. First layer of casting shall be done with Isothalic Gel Cote and Brown Resin Pigment colour. Second layer of casting shall be done by using surface matting. Other two layers shall be with Glass Fibre (CS Mat – 450E) and Resin. Joining of parts shall be done from inside of the statue with Glass Fibre.
  - b) On completion of casting work, finishing and filling job of statue should be done nicely by using resin putty.
  - c) After putty finish all statues are to be coated by ICI making DUCO NC Surfacer. On completion of surface coating, painting shall be done with proportionate mixture of ICI make Belco Metallic Colour (Code: Silicon Gold 51-5019) and hardener. First two layers of painting shall be done with Belco Metallic Colour. The final and the finishing of the painting has to be done with proportionate mixture of Artist oil and Enamel colour.
  - d) Each of the casted bust should have Two numbers of M12X15mm bolt fitted at the bottom side of the base for mounting on the pedestal.
  - e) Fabrication stages:
    - The cast bust shall be inspected by the authority before paint finish.
    - The complete bust shall be inspected by the authority before delivery

Note: Two parts of Latex mould of ‘Bust Portrait’ and Fiber Moulds of Spectacles shall be provided by this office. All other required materials of approved sample shall be arranged by the contractor. Sample of all raw materials must be got approved from the competent authority of the Council. Special care should be taken while making Fibreglass Casting from Latex mould. In case of any damage / breakage of ‘Mould’, the contractor has to make arrangement for making the new mould at his risk, cost and responsibility.

The contractor must obtain approval of the competent authority after completion of every stage of fabrication of the aforesaid job. Bulk supply shall be made only after obtaining sample approval from the competent authority of the Council.

**The total job has to be finished and supplied at site within 45 days of entering into the contact.**
