- **3.** The instructions given in **"Instruction for Online Bid Submission**" should be strictly followed during submission of the Bid.
- **4.** Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 5. Bid should be submitted along with the Earnest Money Deposit (EMD) of Rs.9,58,000.00 (Rupees nine lakhs fifty eight thousand only) by way of crossed Demand Draft/Pay Order/drawn on any nationalized bank of India payable in favour of "NATIONAL COUNCIL OF SCIENCE MUSEUMS, KOLKATA". After fund transfer, the details such as UTR Number, date etc. shall be typed in the letter head of the Bidder and uploaded separately in Cover-I.

Earnest Money deposit in the form of Bank Guarantee bond or any other bond shall not be accepted and shall be rejected straightway. Earnest Money deposits in respect of such offers which are not accepted will be returned to the bidders within 30 working days from the date on which the final decision is taken about the source from which the items under tender are to be procured or within 2 (two) months from the date of the opening of the financial bids, whichever is earlier. No interest will be paid on the Earnest Money deposited with NCSM. Earnest Money deposit in respect of the successful bidders will be retained with NCSM until entire execution of the order as per terms of the tender including defect liability period and two years Comprehensive AMC period. If the successful bidder fails to execute the order strictly as per the Council's Scope of work, Bill of Quantities, Technical Specifications and Terms & Conditions in full within the stipulated completion time of the order, the Earnest Money Deposit retained with the Council shall be forfeited forthwith after cancellation of the concerned order.

- 6. Validity of Bids: The Bids should remain valid for 90 days from the date of opening of financial bid.
- **7. Rejection of Bids:** Canvassing by the Bidder(s) in any form, unsolicited letter and post- tender correction may invoke summarily rejection of their bid(s). Conditional tenders will also be rejected. Non-compliance of applicable General Information and Instructions will disqualify the Bid.
- **8.** The Bidders should have Digital Signature Certificate (DSC) for filling up the Bids. The person signing the tender documents should be authorized for submitting the on line e-tender.
- 9. The Bidders shall fill up the Prescribed Format for submission of Technical (Techno-commercial) Bid as per "Annexure-B" format duly signed by the authorized signatory. The person signing the tender document should be authorised for submitting the online e-tender.
- 10. The Financial Bid shall be filled in and signed by the authorized signatory online as per format"Annexure-C"available at Central Public Procurement Portal e-tender system website http://eprocure.gov.in/eprocure/app. Off line Financial Bid shall not be accepted.
- **11.** Tender must be uploaded in two separate covers marked **Cover-1** (Technical Bid) and **Cover-2** (Financial Bid/BOQ).The contents of Cover-1 and Cover-2 shall be as follows:-

- i) "Technical (Techno-Commercial) Bid" (as per **Annexure-B** format) duly filled in and digitally signed with official stamp.
- ii) All relevant documents related to "Technical (Techno-commercial) Bid" as per "Annexure-B".
- iii) The Technical Brochures of each equipment with technical explanation for every feature of the product offered by the bidders.
- iv) The scanned copy of the Demand Draft for Rs.9, 58, 000.00 (Rupees nine lakhs fifty eight thousand only) as Earnest Money Deposit. In case of online transfer of money, the UTR No. of the transaction shall be prepared in the letter head of the bidder/consortium and uploaded.
- v) The scanned copy of "Scope of Work, Bill of Quantities, Terms & Conditions etc. (Annexure-A) duly signed by the Authorized Signatory with official stamp as a token of acceptance of the same by the bidders.

Cover-2

- i) The "Financial Bid (BOQ)" (as per Detailed Scope of Work and Bill of Quantities) i.e. Schedule of Price Bid in the item wise tabular format duly filled in and digitally signed. The Bidder shall fill up the percentage below/above/at par as per the BoQ.
- ii) "Cost Break-up" for each quoted components (as per Detailed Scope of Work and Bill of Quantities) duly filled in tabular format and digitally signed with official stamp.

The Cover-1, i.e. Technical (Techno-commercial) Bid shall be opened by NCSM at the first instance and evaluated by the competent authority. At the second stage, the Cover-2 containing Financial Bid of only techno-commercially acceptable offers shall be opened for further evaluation and ranking before awarding the contract.

Instructions for Online Bid Submission

- 1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
- 2. More information useful for submitting online bids on the CPP Portal may be obtained at https://eprocure.gov.in/eprocure/app

A. REGISTRATION

- 1. Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online Bidders Enrolment" on the CPP Portal which is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.) with their profile.
- 5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6. Biddersmay then log-in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

B. SEARCHING FOR TENDER DOCUMENTS

- 1. There are various search options built in the CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- 3. The bidders should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

C. PREPARATION OF BIDS

- 1. Bidders should take into account the original e-NIT/RFP and any subsequent corrigendum published on the tender document before submitting their bids.
- 2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- Bidders, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

D. SUBMISSION OF BIDS

- 1. Bidders should log-into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidders will be responsible for any delay due to other issues.
- 2. The bidders have to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3. Bidders have to select the payment option as "online or offline" to pay the requisite Earnest Money Deposit (EMD) and enter detail of the instrument.
- 4. Bidders should submit the EMD as per the instructions specified in the tender document. The original EMD instrument should be posted/couriered/given in person to NCSM, latest by the last date of bid submission. The detail of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5. A standard Price Schedule format (BOQ) has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file (ratequotesheet for Façade Lighting), open it and complete the

bluecoloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidders). No other cells should be changed. In case no rate value is required to be quoted in any particular cell, that cell may be kept blank, figure '0' (zero) shall not be entered in such cell(s). Once the details have been completed, the bidders should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidders, the bid will be rejected.

In addition to the above the **Cost Break-up** shall be submitted in tabular format duly digitally signed with official stamp.

- 6. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9. Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message and a bid summary will be displayed with the bid number and the date & time of submission of the bid with all other relevant details.
- 10. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

1. Introduction:

National Council of Science Museums, Ministry of Culture, Government of India invites offers/bids from reputed and experienced agencies in the field of dynamic artistic architectural façade lighting design and setting up of high quality light fittings and fixtures at museum/Art Galleries/exhibition/public space, especially in the field public/private museums for undertaking the work of as per the tender at National Gallery of Modern Art, Jaipur House, New Delhi.

- i. Brief Information of National Gallery of Modern Art: Inaugurated during the first decade of the Independence of India, the National Gallery of Modern Art opened in March 1954. The choice of Jaipur House, one of the premier edifices of Lutyens' Delhi, signified the envisaged high profile of the institution. Designed by architect Charles G Blomfield, as a residence for the Maharaja of Jaipur, the butterfly-shaped building with a central dome was built in 1936. It was styled after a concept of the Central Hexagon visualised by Sir Edwin Lutyens. Along with buildings designed for other princely potentates like Bikaner and Hyderabad, Jaipur House girded the India Gate circle. NGMA is the premier institution of its kind in India. It is run and administered as a subordinate office to the Department of Culture, Government of India. The NGMA has two branches one at Mumbai and the other at Bengaluru. NGMA with 17,000 works (approximately) is a repository of the cultural ethos of the country and showcases the most significant changing art forms through the passage of the last hundred and fifty years starting from 1857 in the field of Visual arts. Today NGMA is visited by over 225.000 people every year.
- ii. The proposed work is meant for the newly restored Jaipur House of the National Gallery of Modern Art (NGMA) situated on the C-Hexagon of the India Gate, New Delhi. Its height is approximately 10meter for main façade and additional 05meter for central dome and its platform and the perimeter of external façade is approximately 300meter (Refer Annexure – I to Annexure - Mfor details) which is required to be illuminated with tasteful and aesthetic façade lighting using the flood lights, spot lights, track lights, etc. on suitably mounted structure / peripheral walls to bring out the full beauty & aesthetic value of it.
- iii. NCSM therefore invites Request for Proposal from Company/Firm/Agency/Consortium with adequate experience, sound financial background and proven capabilities for Conceptualisation, Planning, Design, Supply, Installation, Testing, Commissioning and Maintenance of Dynamic Artistic Architectural Façade Lighting System
- iv. Bidders who are interested to participate should meet the eligibility criteria and submit their duly completed RFPs along with all the required documents in support of their eligibility qualification.

v. If at any stage, it comes to the notice of NCSM that any successful/qualified bidder had misrepresented the facts/falsely claimed any qualification while submitting his RFP or at any time subsequently, the agency will be disqualified. And in any such instance, NCSM also reserves the right to take any further action against such bidder under law.

2. ELIGIBILITY CRITERIA:

- i. Company/Firm/Agency/Consortium shall have the experience of implementing Façade Lighting projects **OR** Company/Firm/Agency/Consortium having experience in installation of hardware equipment in the Lighting of Sound & Light Shows / Laser Shows or on Monument or Notified Buildings / Museums etc.
- ii. The bidder could be an Individual, Limited Company/Corporation, Proprietary Firm, Partnership etc. Consortium or Joint Venture are allowed to bid for the Works.
- iii. The bidders should have minimum experience of **5 years** since their establishment. For establishing the same, the bidder should submit copies of work orders issued on them as well as copies of work completion certificate of the same work.
- iv. The Average Annual Turnover of the Bidder (of the lead partner in case of consortium) for last three financial years should be minimum **INR 4 Crore**.
- v. The Bidder should have the requisite work experience of working on similar projects during the last 5 years ending last day of month previous to the date of issuing of RFP as per the details given below. It may be noted that the evaluation shall be done as per the marking scheme given in the clause 8(C)

One similar work of value not less than **Rs. 3.00 Crore** of the estimated cost of work.

Or

Two similar works each of value not less than Rs. 2.25 Crore of estimated cost of work.

Or

Three similar works each of value not less than Rs. 1.50 Crore of estimated cost of work.

Notes:

Here the **similar works*** means the work of Conceptualisation, Planning, Design, Supply, Installation, Testing and Commissioning of External Dynamic Façade Lighting works in Heritage or Monument or Notified buildings and Museums.

The details of qualifying works/projects shall be furnished as per the proformain**Annexure-D** and if required the bidder shall also facilitate inspection of the above qualifying project(s) by NCSM's officials to ascertain the performance of the system.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid or extended date of submission of bid.

vi. NCSM may inspect any of those at its discretion to verify the credentials of the bidder for the qualifying works/ projects indicated above for which the Bidder shall provide references (including Referee names and contact details) in respect of the projects implemented.

For the purposes of determining Conditions of Eligibility and for evaluating the Proposals under this RFP, following projects shall be deemed as Eligible Projects - Similar works as mentioned in Notes under point (v) of Eligibility Criteria for Monument / Museum / Parks / Lakes / Landscape / Aquatic Illumination / Memorial / Buildings reflecting Heritage / Ethnic / Cultural themes / Convention Centre / Luxury Hotels / Resorts / Institutional Campus.

The bidder should provide documentary proof for the above in the form of a work order / supply order / contract document / testimonial.

- vii. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:
 - Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
 - Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

viii. Proof of Concept (PoC)

- a. The applicants shall be advised to present a proof of concept (PoC) i.e. scheme for illuminating the external surface / façade of the building using lighting modelling software (such as: DiaLux, ReLux or any other such open licensed software). The details of the building such as AUTOCAD drawings (plan and elevation) shall be shared with the applicants on request.
- b. The light fittings used in the model should be LED type only and the colour of the light shall be controllable using an external/internal controller.
- c. The software model shall indicate the lumen output contour lines on the building external surface, and power consumption details.
- d. The bidder shall also submit the REVISED Bill of Quantity along with the itemised cost breakup (as mentioned in scope of work) required to execute the dynamic façade lighting works as per their submitted model. However, the total cost of the revised Bill of Quantity should not exceed the quoted price of the bidder.
- e. Further requirement if any regarding the presentation shall be communicated in due course.

Note: The bidder shall approach NCSM for required drawings. The bidders should be ready for the demonstration of Proof of concept (PoC) on short notice, say 3 days from the communication from NCSM.

3. SCOPE OF CONTRACT

The successful e-tenderer shall carry out and complete the works in every respect in accordance with this contract and in accordance with the directions of the Engineer and to the satisfaction of the Engineer and the NCSM/NGMA. The Engineer may from time to time issue further drawings and/or written instructions, detailed directions and explanations in regard to:

- (a) The variation or modification of the design, quality or quantity of works for the addition or omissions or substitution of any work.
- (b) Any discrepancy in the drawings or between the schedule of quantities and/or drawing and/or specifications.
- (c) The removal from the site of any material brought therein by the successful e-tenderer and the substitution of any other materials there from.
- (d) The removal and/or re-execution of any works executed by the successful e-tenderer.
- (e) The dismissal from the works of any persons employed thereupon.
- (f) The opening up for inspection of any work covered up.
- (g) The amending and making good of any defects.
- (h) The successful e-tenderer shall comply with and duly execute any work comprised in such instructions, detailed directions and explanations, provided always that if the Engineer's instructions involved variations from the priced Schedule of Quantities, such instructions shall be issued by the Council and the successful e-tenderer shall take appropriate action.
- (i) Even if not specifically mentioned in the schedule of quantities, the successful e-tenderer shall be deemed to have allowed necessary material, labour, tools and plants etc. required for satisfactory completion of the items of work as indicated in drawings and description given in the specifications, which are attached herewith unless the item specifies labour only or otherwise.
- (j) Rates quoted also apply for work in patches, strips, small or large areas, and for different shapes and in different sizes and in different planes (Horizontal/vertical or inclined).

(k) SUCCESSFUL E-TENDERER TO PROVIDE EVERYTHING NECESSARY

The successful e-tenderer shall provide everything necessary for the proper execution of the works according to the true intent and meaning of the drawings and specifications and bill of quantities taken together, whether the same may or may not be particularly shown on the drawings or described in the specifications or included in the bill of quantities, provided that the same is to be reasonably inferred there from and if he finds any discrepancy in the drawings, or between the drawings and specifications and bill of quantities, he shall immediately refer the same to the Engineer who shall decide which shall be followed. Figured dimensions shall be followed in reference to scale.

(I) RATES

The rates quoted by the Successful e-tenderer shall be paid at net rates. He should include in his rates allowance for increase or decrease in the prices due to market fluctuation. He shall not be entitled to any separate amount on account of GST, other taxes, Labour Cess, duties etc. which are in force or will be enforced or enhanced by

Government or local bodies during contract period or after e-tendering. Accepted e-tender rates shall not be changed due to changes in wages of labour either.

The rates considered in the respective items are inclusive of comprehensive maintenance of the entire system for a period of twoyears after completion of the defects liability period of 1 year post the actual satisfactory completion of the entire work in all sense. (Total comprehensive maintenance period of 3 years including Defect Liability period of 1 year)

(m) QUANTITIES

All the quantities given in schedule of quantities are provisional.

The e-tenderers shall be deemed to have given Balanced Rates for each item, irrespective of the quantities given. Also irrespective of variation in quantities to any extent the e-tenderer shall be paid at accepted contract rates only. **NCSM reserves the right to increase or decrease quantities to any extent.**

4. SCOPE OF WORK

NCSM desires to provide an external Dynamic Artistic Architectural Façade Lighting System at NGMA (Jaipur House), New Delhi. The said building is a G+1structure with a dome at the centre and a height of 10 meter for main façade and additional 05 meter for central dome and its platform and the perimeter of external façade is approximately 300 meter (Refer to Annexure – I to Annexure - M for details). The façade of the building is required to be illuminated using LED floodlights, Linear LED wall-washers, LED spot lights, LED uplighters, LED CoB spotlights, LED GOBO projector, LED strips, etc.

Within the quoted rates, the successful bidder will also provide comprehensive maintenance services for the subject façade lighting system installed by them for the defect liability period of one yearwithout any additional cost.

After the expiry of the defect liability period of one year, the Comprehensive Annual Maintenance Contract for two years will be executed withNGMA. This two years Comprehensive AMC is the part of the scope of work within the quoted rates by bidders.

The project/work is to be completed within **5 months** from the date of issuance of the work order/LOI.

The Scope of Work of the project project includes the following major components:-

a. Creative Lighting Concept, Plan & Design

- i. The lighting design should create an overall aesthetic look of the heritage structure and highlight the features and architectural details. Flat flood lighting should be avoided.
- ii. The use of cost-effective LED light fixtures is encouraged. All lights and control gear should be high quality, A-grade, long life equipment.

b. Control System & Cabling Design

- i. Design of the control system and system integration to provide dimming of various fixtures in order to balance light levels to create an aesthetic look. It should be possible to program and save various schemes as pre-sets which can be easily recalled from a touch interface.
- ii. A single point of control should be provided for the entire installation using industry standard protocols like DMX/DALI/WiFi/KiNet, etc for a third Party integration and control if & when required.
- iii. Design of the cabling to include power and data cables for least intrusive installation so that it does not mar the beauty of the recently restored building.

c. Bill of Quantity/Material

- i. Preparation and the specification of the hardware requirement and the Revised Bill of Quantity.
- ii. A tentative BOQ has been provided in the RFP document along with approved makes/manufacturers/suppliers. Reasonable variations to this are allowed with proper justifications, without any variation in the final cost quoted by the successful bidder in the financial bid.
- iii. Post installation, the support should be on 'No cost, No commitment' basis till the time the equipment is under warranty (defect liability) clause. (**Milestone 1**)

d. Supply, Installation, Testing and Commissioning of Hardware

- i. Supply, installation, testing and commissioning of the light fixtures including making of suitable & sturdy mounting arrangement, junction boxes, terminations.
- ii. Supply, installation, testing and commissioning of the electrical panels & switchgear, cables and wires, earthing pits and earthing cable. (**Milestone 2**)

e. Programming System, Integration & Soft Commissioning

- i. System Integration and addressing of fixtures for ease of control.
- ii. Programming of colours and lighting levels to create various pre-set schemes, saved to a touch controller.

f. Modifications/ Alterations:

After the setup is soft commissioned, the same will be reviewed by the Client. Upon such review, if there be any suggestion in the concept/integration etc. received from the Client, will need to be incorporated (within reason) without any extra cost before the work is finally commissioned and taken over. (**Milestone – 3**)

g. Training toNGMA Staff

- i. Provide training to the client/owner's staff including the day to day operation & maintenance with minor repairs.
- ii. Hard copy of ready reckoner (Manual) for the daily operation, checking and diagnosis of day to day faults repairable by client staff should be provided. (**Milestone 4**)

h. <u>One Year Defect Liability Period and additional Two years of Comprehensive Annual</u> <u>Maintenance</u>

- i. The bidder will be required to provide comprehensive maintenance services for the subject façade lighting system installed by them for the defect liability period of one year without any additional cost. (**Milestone 5**)
- ii. Prior to the expiry of the defect liability period of one year, the Comprehensive Annual Maintenance Contract for two years will be executed by the successful bidder with NGMA within the rates offered by them.
- iii. The successful bidder is supposed to maintain minimum spare at the site in order to keep the downtime less than 24 hrsandis required to complete the two years comprehensive AMC successfully. (Milestone – 6)

5. EARNEST MONEY DEPOSIT (EMD)

- i. Proposal should necessarily be accompanied by an Earnest Money Deposit for an amount of `9.58Lacs(i.e. 2.5% of estimated cost of the work) in the form of Account Payee Demand Draft/Banker's Cheque/NEFT transfer to NCSM's bank account as per bank details provided in the term sheet. EMD instrument must remain valid for a period of 90 days beyond the final proposal/bid validity period.
- ii. Bids not accompanied by Earnest Money Deposit of the requisite amount with proper validity will be summarily rejected.
- iii. Exemption of depositing EMD is allowed only to the MSME/NSIC registered bidders.

Document required for availing exemption of EMD for MSME's registered with NSIC: The following procedure is adopted for the bidders of MSME's registered with NSIC: The MSMEs who intent to claim benefits under MSME act, shall fulfil the following, otherwise they run the risk of their bid being passed over as "INELIGIBLE" for the benefits applicable to MSME's and their bid will not be considered for evaluation.

- a. MSMEs which are specified by the Ministry of Micro, Small and Medium Enterprises under MSME Act 2006and Public Procurement Policy, 2012 as Manufacturing/ Service Enterprises should have registered with NSIC under its Single Point Registration Scheme (SPRS).
- NSIC certificate with monetary limit indicated should be valid on the scheduled date/ extended date of submission of tender. Certificates without monetary limit will not be considered.
- c. The items of Product/ Services mentioned under NSIC certificate should be the same or similar to the tendered items
- d. The monetary limit stipulated in the NSIC certificate of MSME's should be equal or more than the value of work(s)/Supply is/are "In hand (Progress)" awarded under

MSME benefits during the financial year plus estimated cost of this tender for availing EMD exemption.

- e. If monetary limit is less than the value of work(s)/ Supply is / are "In hand (Progress)" awarded under MSMEbenefits during the financial year plus estimated cost of this tender, they should obtain "Competency Certificate" from NSIC for participating in this tender as well as to avail MSME benefits. The competency certificate should be uploaded along with the tender document.
- iv. The EMD amount shall not bear any interest payable by the NCSM to the successful bidder/un-successful bidder.
- v. EMD of successful bidder shall be retained by the NCSM which will get converted into Retention Money/ Security Deposit is submitted by the successful Bidder. Whereas, EMD of the unsuccessful bidders will be returned after expiry of the final proposal/bid validity and latest on or before the 30th day after the award of the contract.
- vi. EMD shall be forfeited and proposal of bidder shall be cancelled in the following cases:
 - a. if any information or document furnished by the bidder turns out to be misleading or untrue in any material respect.
 - b. if the successful bidder fails to execute the Agreement within the stipulated time as per the format of the Article of Agreement as given in this RFP/NIT document in Annexure - H.

6. <u>RETENTION MONEY/SECURITY DEPOSIT:</u>

- i. This shall mean and be 10% of the total cost of work awarded or the final gross value of work done & paid against this contract, whichever is greater.
- ii. The Retention Money or Security Deposit will be deducted & retained @10% of the value of work done & paid through every interim bill which will be inclusive of the Earnest Money already deposited by the successful bidder along with the bid/tender.
- iii. The Retention Money or Security Deposit so retained shall not carry any interest thereon.
- iv. 50% of the Retention Money or Security Deposit shall be refundable to the successful bidder after satisfactory completion of the Defects Liability Period post actual successful completion of the work in all respect & handing over as detailed under TERMS OF PAYMENT.
- v. Balance 50% of the Retention Money or Security Deposit shall be refundable after satisfactory completion of the Comprehensive Annual Maintenance Contract with NGMA for a period of 2 years post the Defects Liability Period of 1 year as detailed under TERMS OF PAYMENT.
- vi. In case of cancellation of the contract, this retention money shall be forfeited and amount necessary to make up this amount shall be recovered from any money due to the successful bidder under this or any other contract with NCSM.

- vii. In case, the successful bidder causes any damage to the property of the Client, the NCSM shall have discretionary rights to execute the repair of damages and recover the amount from the successful bidder or to adjust the equivalent amount from the successful bidder's Security Deposit.
- viii. In case of death of successful bidder, Security Deposit shall be returned /refunded to the legal heir of the successful bidder after adjustment of dues, if any post the actual completion of the work & upon expiry of the specified guarantee/defects liability period as well as satisfactory completion of CAMC period of two years post the Defect Liability Period.

7. JOINT VENTURES/CONSORTIUM

- i. In the event that the successful bidder is a consortium/joint venture formed, lead partner/prime contractor in whose name the bid was issued, shall be fully and solely responsible for the performance of contract and all works designed and executed under the contract.
- ii. Bids submitted by a consortium or joint venture of maximum two firms including lead partner, all partners shall comply with the following requirements:
 - a. The consortium as a whole must be a sound entity technically and the lead partner must be sound entity financially.
 - b. The Consortium as a whole must satisfy the qualification criteria set forth herein. The turnover of lead partner must satisfy the eligibility criteria of the tender. The bid shall contain a statement of the members of the consortium and shall provide all information necessary to satisfy Client/Employer that the Consortium fulfils the qualifying criteria.
 - c. The Bids shall contain original copy of the Memorandum of Understanding (MOU) on Rs.100. Non-Judicial Stamp paper (or as applicable) between the consortium members clearly identifying the lead partner, scope and responsibility and financial part of each member in the performance of the contract.
 - d. The consortium members will obtain approval of the Client for any change in the shareholding structure and scope of work or any other terms of MOU.
 - e. The lead partner of the consortium shall be nominated as being in-charge to represent the Consortium in all dealings with the Client/Employer and for providing any information or clarification sought from the Consortium.
 - f. The Bid shall be signed by all the consortium firms by their authorized person. The lead partner shall be authorized to incur liabilities and receive instructions for and on behalf of any and all member(s) of the Consortium and all dealings including billing and payments, shall be done exclusively with the leader of the consortium.

- g. Only firms or joint ventures that have been qualified under this procedure will be eligible to bid for this project.
- h. All members of the Consortium shall be liable for the execution of the project in accordance with the terms of the MOA and Contract agreement.
- i. Any individual bidder or member of a consortium cannot be member in another consortium and participate in this tender.
- j. All correspondence or communications will be done by the Lead partner (or authorized representative of Lead partner) of consortium.
- k. Net worth as on the last day of the preceding financial year should be positive during the preceding three consecutive financial years.
- I. Bidder submitting their bid shall not be under liquidation, court receivership or similar proceeding.

Notes:

- 1. Technical bids of the agencies that fulfil the above pre-qualification criteria shall be opened.
- 2. The bidder has to upload the compliance letter on its letterhead duly signed by the authorized signature & other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of the bid.

8. PROPOSAL EVALUATION / SELECTION CRITERIA

A three-stage procedure under Quality Cum Cost Based (QCBS) Evaluation will be adopted in evaluating the proposals

- i. Eligibility Criteria Evaluation: Any short coming of the documents will lead to rejection of the bid and other envelope will not be opened.
- ii. Thematic/TechnicalPresentation Evaluation: The agencies qualifying on the basis of their credentials evaluation will only be called for Thematic /Technical Presentations which can be at a very short notice of even three days.
- iii. Financial Evaluation: Only the bidders/firms securing the minimum qualifying marks based on Eligibility Criteria Evaluation and Technical/Presentation Evaluation as described in details below will be eligible for their Financial Bid Opening & Financial Evaluation.

A. <u>Technical Evaluation</u>

i. The Evaluation Committee appointed by the Client shall carry out its evaluation applying the evaluation criteria specified in the bid document. Evaluation of the application would be done as per the documents submitted. Bidders/agencies who are in the trade and are fulfilling the pre-qualification criteria as per the documents required would only be called for thematic presentation which can be at a very short notice of even three days.

- ii. Further during the technical presentation the evaluation would be carried out on Quality and Cost Based Selection (QCBS) basis where the Technical cum creative evaluation would be given upto 100 marks.
- iii. Each responsive proposal shall be attributed a technical score. On the basis of the technical assessment, **agencies securing minimum 75 marks out of 100 will** be shortlisted and the financial bids of **only** the shortlisted agencies will be opened. The date and time of opening of the financial bids will be intimated to the selected /shortlisted agencies through CPP portal.

B. Financial Evaluation

Quality and Cost Based Selection (QCBS)

Under the Quality and Cost Based Selection (QCBS) basis, the **weightage to Technical and Financial Bids would be 70% and 30% respectively.**

i. **Technical Bid**: The total marks obtained out of 100 marks in technical bid shall be scaled down to a maximum of 70 as follows which shall henceforth be the total marks obtained by the bidder against the technical bid.

Marks (max 70) on technical Bid (A) = 0.70 x Marks of Technical Bid under evaluation.

ii. Financial Bid: The lowest financial bid would be the best financial bid and shall be awarded 30 marks. Other financial bidders would be awarded marks out of a maximum of 30 based on the following formula:

Marks (Max 30) on Financial Bid (B) =0.30 X (Lowest Financial Bid) x 100 ÷ Financial Bid under Evaluation.

The bidder scoring maximum total marks $\{(A) + (B)\}$ would be recommended for selection.

Notes:

Technical Bids will be evaluated on the basis of documents as detailed above & Presentations to be made by the eligible agencies before the Constituted Committee. The date and time of the presentations will be conveyed to the eligible agencies.

9. COMPLETION TIME

The project/work is to be completed within **5 Months** from the date of issuance of the work order/LOI.

10. DEFECT LIAB ILITY PERIOD and COMPREHENSIVE ANNUAL MAINTAINENCE CONTRACT

- i. **Defect Liability Period (DLP) shall be of ONE YEAR** from the date of actual satisfactory completion & handing over of the entire job as certified by the authorities of NCSM/NGMA.
- ii. The Comprehensive Annual Maintenance Contract (CAMC) will be of TWO YEARS and will commence from the date of satisfactory completion of the Defect Liability Period.
- iii. During the Defect Liability Period and the Comprehensive Annual Maintenance Contract Period, the successful bidder within their quoted rates shall service & maintain the entire façade lighting system installation with all its control units & other accessories, rectifyany or all the observeddefects or any or all the defects as pointed out to them within a reasonable time, as decided by the competent authority of NCSM/NGMA.
- iv. During the DLP as well as the CAMCP, minimum 1 visit per quarter will be given by the Service Engineer/Technician of the successful bidder for a thorough inspection, checking, repairs & maintenance of the entire façade lighting system for which all tools, tackles and material including spares as well as the required skilled/specialised manpower shall be arranged by the bidder at their expenses & risk.
- v. Apart from the routine quarterly visits as above, whenever the successful bidder is called for providing any kind of repairs/maintenance, they shall render all such services within a reasonable time, any number of times within the quoted rates and at no extra cost or expenses whether during the DLP or the CAMCP.
- vi. A register of such visits during DLP & CAMCP as well as a log-book of services rendered/ major works done shall be maintained wherein counter signatures of the authorised NCSM/NGMA representative shall be obtained from time to time.
- vii. A penalty in the form of deduction as deemed fit by NCSM/NGMA authority shall be applied and be deductible from the Retention Money / Security Deposit of the bidder for any lapse in providing services, rectifying defects or in case of an inordinate delay in attending the faults/defects or responding to the service/breakdown calls.
- viii. If the successful bidder fails to rectify the defects within a reasonable time, such defects will be rectified by NCSM/NGMA by engaging departmental staff or outside Agencies at their discretion, and the cost thereof, as decided by NCSM will be deducted from the Retention Money / Security Deposit of the successful bidder retained by NCSM.

ix. The bidder may separately prepare & upload a detailed scope of CAMC with other terms & conditions on their letter head which will be mutually modifiable with the successful bidder during the execution of the work and the DLP.

In case of the work is carried out in phases, total payment admissible will be computed on pro-rata basis based on completed percent of work vis-à-vis total work under consideration.

All payments, as above, shall become payable within fifteen days of submission of the respective invoices. The payment shall be transferred to the bank account of successful bidder through electronic transfer only, for which the bank details of the bidder has to be provided with each invoice.

Statutory deductions/recoveries viz. TDS, TDS GST, Labour Cess, etc. shall be made as per the relevant provisions from the payment due to the bidder from time to time.

12. OTHER TERMS AND CONDITIONS

- i. The successful Bidder shall submit within 3 (three) days from the date of placement of the work order the duplicate copy of the work order duly signed with official stamp on all the pages as a token of their acceptance of the work order/Lol.
- ii. In case the successful bidder refuses to accept the offer after finalisation or does not comply with sending of acceptance of the order within 03 (three) days from the date of placement of the order as per the finalised and accepted terms & conditions, earnest money deposit would be automatically forfeited and the order shall be cancelled forthwith.

iii. Penalty Clause :

In case of non-completion of the entire work within the stipulated time, and the delay is not attributable to site requirements, Liquidated Damage (L.D.) @1% per weekof the total cost of work awarded subject to a maximum of 10% of the gross value of work done or cost of work awarded, whichever is greater, shall be recovered from the bill of the successful bidder.

- iv. The authorities of NCSM do not bind themselves to accept the lowest tender and reserves the right to accept or reject any or all tenders wholly or partially without assigning any reason whatsoever.
- v. The quoted rate shall remain unchanged during the entire contract period.
- vi. The successful bidder shall be liable for depositing all taxes, levies, cess, etc. on account of service rendered by it to concerned tax collection authorities from the time to time as per extant rules and regulations on the matter.
- vii. The successful bidder shall maintain all statutory registers under the applicable laws. The bidder shall produce the same, on demand, to the concerned authority of this Office or any other authority under Law.
- viii. The Tax Deduction at Source (TDS) shall be effected, as and when applicable, as per the provisions of Income Tax Act, as amended from time to time and a certificate to this effect shall be provided to the bidder/contractor/supplier by this Office.

All disputes and differences of any kind whatever, arising out of or in connection with the contract on the carrying out of works (Whether during the progress of the work or after their completion and whether before or after the determination, abandonment or breach of the contract) shall be referred to arbitration as per Clause 11(xvi) of Annexure Aof the said conditions of contract. In case of any legal dispute, other than the arbitration, the court of jurisdiction shall be at the place written in the first line of this agreement.

The provisions of the Arbitration & Reconciliation Act 1996 or any statutory modification or reenactment thereof and of the rules made there under for the time being in force shall apply to arbitration proceedings under this clause.



A. Front Façade of Jaipur House, NGMA




