We request you to kindly widen the definition of Similar Works in order to ensure sufficient participation of capable entities in the bidding process to ensure successful closure of the bidding process.

Highly restrictive qualification criteria only works against the benefit of the project. Many times last year itself due to fewer participation of entities in the bidding process the entire bidding processes have been scrapped with no outcome.

And, The provisional Light and Sound shows are much more challenging due to their short term implementation timelines, lesser time available to curate and deliver, dynamic nature of structure and usage / demand of latest tech equipment, enriches the Agency's team and experience multi-fold and makes us far more adapt & exposed to the challenges of a Sound and Light Show Solutions and makes us capable of delivering much more successful and extravagant Light and Sound Show Solutions.

In view the above, kindly amend the definition of Similar Works:

"SIMILAR WORKS shall mean concept, design, supply, installation, testing and commissioning of classic sound & light show/ projection mapping-based sound & light show/ laser show.

4. General Eligibility. Notes, Pg 13-14:

If any bidder has executed the similar work as a part of a consortium/JV in the past then the work experience of the bidder shall be considered as valid only if all the consortium/JV partners are participating together in the present RFP also.

This is an extremely restrictive condition. JV are specific project, specific time bound associations formed between companies to improve their capability and capacities.

A lot keeps changing in the business dynamics between two companies and with growth comes self-sufficiency or alignment with a better partner. How is this condition helpful in finding the right agency for executing this project? There may be cases where past JVs did not work well for the project and this condition forces past JVs only to participate as JVs

Why are companies being forced to enter into JV with the same company that they may have done a JV years back and may / may not have a favourable business association anymore

Suggestion: This condition should be removed

Since the project is of special nature, all those works that are similar to the project in question have been already added. Since Light and Sound show doesn't require any 3D graphic generation and mapping on the façade, considering only Light and Sound shows is difficult. However, if the light and sound show is developed in combination with the projection mapping show then that will be considered as eligible.

Please see the clarification in D (4)

5. Clause No. 8: Completion Time:

The project/work is to be completed within 2 Months from the date of issuance of the work order/LOI.

Basis of our experience of curating more than 8 shows as of now, we can submit that complete curation of project of such nature takes atleast 3 months from start date (this time is primarily required for Research, Script creation, approval, iterations, changes, music and VO creation, changes and approvals).

Suggestion: Completion time may be increased to 3 to 4 months

The project is strictly time targeted. No extension of time is possible.

6. Clause 10: terms of Payment

Yet again, the terms stated here have been defined as basic supply and installation of hardware, while in such a project considerable time, money and efforts are invested in Show content planning and curation. Therefore we request that Payment terms may be amended as:

Suggestion:

- Approval of Project Implementation Plan including project layout plan, simulated video, 3D rendering, technical details of the components such as capacity, make, quantity etc. which shall be used for project – 5%
- ii. Approval of content, narrative description, script and voice-over and other creative audio visual components 15%
- iii. Physical Installation of equipment, hardware, machinery and other required fixtures at the Project Site 25%
- iv. Successful Trial Run of the Project and approved by the Authority 25%
- v. Successful running of the Project for a continuous period of 30 days after issuance of Project Commissioning Certificate meeting all project requirements as stated in the Contract Agreement 20%

On Successful running of the Project/ Show during O&M Period (amount be paid at the end of each quarter of O&M Period beginning from the date of issuance of Project Commissioning Certificate by the Authority) – Remaining 10% of Bid Price shall be divided equally in quarterly payments during O&M Period

You will appreciate the fact that short-duration installation of sound & light show on multiples times requires more technical knowhow, precision and strong O&M capabilities than a project of permanent nature where operator is

Since the duration of the project is very small, splitting the payment terms as proposed is not possible. It is seen from the past experience that many of the agencies purchase the high value equipment of loan and they are in a hurry to clear their dues. Considering this the payment terms have been devised. However, there is a small clarification regarding payment during O&M which is clarified in Point J (9).

O&M also requires maintenance of many high value equipment for which special technical expertise is required in the agency. Past experience in this regard will help in assessing the technical capabilities of the agency and hence finds its place here.
