Based on the suggestions made by the Governing Body, NCSM in its 129th meeting held on 28.05.2021 and on the recommendations of the committee constituted for examining inclusion of left out existing employees/pensioners/family pensioners in NCSM Employees Health Scheme (NEHS), it has been decided that willingness from such personnel who did not exercise their options to become members of the said scheme at the first and second instances, may be obtained.

As such all officers and staff members/pensioners/family pensioners of NCSM, who did not exercise their options to become members of NEHS earlier, are requested to send their willingness in the enclosed form to the undersigned latest by 31.08.2021. They are however, required to join against payment of lump sum amount equivalent to 10 years' contribution on proposed revised rate (life time contribution) together with applicable bank deposit interest rate to be fixed by NCSM w.e.f. 01.01.2016 depending on Grade Pay/Pay Matrix Level while in service or at the time of retirement as due on the date of becoming life time member of the scheme. It may be noted that no further chance or opportunity will be given beyond 31.08.2021.

The willingness of the intended employees/pensioners/family pensioners would be placed before the aforesaid committee for consideration & recommendation and only on approval of the Competent Authority, the facility of NCSM Employees Health Scheme (NEHS) will be extended to the willing personnel who have exercised their option on or before 31.08.2021.

- 2. During the lifetime of each pensioner/family pensioner and other beneficiaries under the scheme, reimbursement may be allowed for any number of critical illness subject to the ceiling of the limit of the reimbursement.
- For new members who would be joining the NEHS scheme from a cut-off date to be approved by GB, NCSM, no reimbursement for critical illness shall be allowed within one year of becoming the member of NEHS.
